Requirements: All canine companions must have proof of current Rabies, Distemper/Parvo, Canine Influenza (H3N8 and H3N2), Bordetella, Heartworm test and fecal prior to admission. All canines must also be on oral flea AND tick prevention (Nexgard or Bravecto). Topical products are not acceptable for boarding purposes. All feline companions must have proof of current Rabies, Distemper, and have a negative FELV/FIV test prior to admission. Should your pet need current vaccinations or tests they will be given at the owner's expense. Should your pet need current vaccinations or tests they will be given at the owner's expense.

All pets boarded with NNVH must be free of live fleas, ticks, and ear mites at the time of arrival. If any of the above are found, the animal may be treated at the owner's expense. If NNVH deems the pet infested the pet will not be admitted into the hospital/kennel and alternate arrangements will need to be made. If the infestation is detected after admittance to NNVH, the owner or owner's agent will be required to pick up the pet and alternate care arrangements will need to be made.

Personal Items: We make every effort possible to make your pet feel at ease while he/she is staying with us. We do not recommend bringing personal items from home as they may get lost in the laundry or soiled. NNVH is not responsible for lost or damaged personal items. You may bring food, treats and a favorite toy, and any medications. Bowls, water, bedding etc. will all be provided for by NNVH.

Medications: A medication per diem charge will be applied to any pet that needs medication, vitamins, or nutritional supplements administered while boarding. All prescription medications must be in their original containers. NNVH is authorized by the owner to provide veterinary care, including emergency care, at the owner's expense. If we believe that your pet is in need of care, time permitting we will attempt to contact you before providing that care, but this document serves as our authorization to provide veterinary care for your pet in the event we are unable to reach the owner. All pets boarded with NNVH found to have signs of contagious illness will be boarded in the isolation unit. Additional charges will apply. The owner is responsible for expenses of veterinary care, whether or not you have been reached in advance. NNVH doctors are on call and reachable to the staff by phone on the weekends to evaluate any medical needs your pet may have. On the rare occasion that a doctor is not local, technicians may be instructed to transfer your pet to an emergency facility if warranted.

Natural Disasters: In the case of a Category 2 or higher storm or other weather event that recommends evacuation, pets will be secured to the best of our ability at our facility. The stall will evacuate as directed and will return to care for your pets when local authorities allow. We will happily release pets to designated representatives prior to hospital closure for the weather event. Please make arrangements for this event in advance with our staff.
